


## ***Highlights of Developments in 2019<sup>1</sup>***

- **Total net assets of UCITS and AIFs grew by 16.8 percent to EUR 17.7 trillion.** After the steep stock-market drop at the end of 2018, both stock and bond markets grew strongly over the course of 2019. This overall market appreciation, combined with solid sales, resulted in a sharp rise of UCITS and AIFs net assets.
- **Net sales of UCITS and AIFs increased to EUR 546 billion, from EUR 258 billion in 2018.** Net sales of UCITS reached EUR 394 billion, compared to EUR 121 billion in 2018. Inflows into AIFs also increased in 2019, to EUR 152 billion from EUR 137 billion in 2018.



- **Bond funds were the bestselling UCITS category in 2019, gathering EUR 301 billion in net new money.** Fear over a global economic slowdown prompted central banks around the world to move towards more accommodative monetary policy. The anticipation that interest rates would stay at very low levels for some time led many investors to invest in bond funds.
- **Equity funds suffered net outflows in 2019.** Equity fund sales were negative for the first 8 months of the year, as investors feared that the weakening of global growth and the trade tensions between the US and China could negatively impact stock markets. As tensions diminished, investor confidence strengthened and net sales of equity funds bounced back.



## Top Ten Domiciles in 2019


### Largest Domiciles in terms of Net Assets and Net Sales

#### UCITS FUNDS








## Highlights of Developments in Q4 2019

- Total net assets of UCITS and AIFs grew by 3.3 percent to EUR 17.7 trillion.** This solid growth in net fund assets was mainly driven by increases in global stock markets.
- UCITS and AIFs recorded net sales of EUR 190 billion,** a similar level of sales as in Q3 2019. UCITS accounted for the largest part of net sales over the quarter (EUR 148 billion), compared to EUR 157 billion in Q3 2019. Net sales of AIFs amounted to EUR 43 billion, up from EUR 33 billion in Q3 2019.










- Demand for UCITS equity funds bounced back.** After 4 consecutive quarters of outflows, UCITS equity fund flows reversed. A tentatively improving economic outlook, supported by decisive monetary policy actions, increased investor confidence. Net inflows of equity funds amounted to EUR 53 billion, compared to net outflows of EUR 12 billion in Q3 2019.
- Multi-asset funds recorded stronger net sales.** Investors' renewed confidence also led to an increase in sales of multi-asset funds. Net sales amounted to EUR 57 billion, up from EUR 30 billion in Q3 2019.
- Net sales of bond funds slowed down.** The bond fund rally subsided in favour of other long-term funds. Still, net inflows into bond funds amounted to EUR 38 billion.
- The demand for ETFs strengthened.** Net sales of UCITS ETFs amounted to EUR 46 billion, almost a third of total UCITS net sales.

### ***Net Sales of UCITS by Investment Type***






### *Net Sales of AIFs by Investment Type<sup>3</sup>*


